**Terms & Conditions**

1. The order for prior permission shall be valid for 2 (two) years only within which the applicant shall have to complete the construction works on its own land and run the School as proposed.
2. The School authority shall constitute the Managing Committee as per Section 12 of the Act.
3. The School authority shall have to fulfill all requirements as required under section 10 of the Act and Rule 7, 8, 9, 10, 11, 12, 13 and 14 of the Rules.
4. The School authority shall prepare a Scheme of Management as required under Section 14 of the Act and Rule 16 of the Rules.
5. The School authority shall apply for Registration of the School in Form- II within a period of 2 years alongwith the copies of all documents.
6. In case of failure to complete the task within the specific period of 2 (two) years, this Order shall stand cancelled.
7. The terms and conditions laid down in the Assam Non-Government Educational Institutions (Regulation and Management) Act, 2006 and Rules, 2007 is to be followed.
8. This permission will not accrue any financial liability to the BTC authority.

**Order**

Perused representation submitted by Rashmi Phukan, HT /HM /Principal, BODOLAND PIONEER PUBLIC SCHOOL (PVT), Kokrajhar District and all the connected papers concerned with the matter of the representation.

In the representation submitted by the petitioner, Rashmi Phukan, it is stated that the school, viz. BODOLAND PIONEER PUBLIC SCHOOL (PVT) (Annexure-A Sl. No.961) was established on /in the year 14.12.2020 and is presently functioning under the BEEO, KOKRAJHAR, Block, Kokrajhar district and applied for allotment of UDISE code & RTE Recognition.

In this regard, as per terms of reference of District Level Redressal Committee (DLRC) re-constituted vide BTC notification No.BTC /Edn (E)-67 /2021 /44 dtd. 20-04-2022, the DEEO, Kokrajhar cum Member Secretary, DLRC has requested Circle Officer and BEEO concerned to enquire into and submit joint enquiry report in prescribed format as per norms for schools as laid down in the RTE Act, 2009 with photograph of school. Now the officers have submitted the joint enquiry report which is placed before the District Level Redressal Committee (DLRC) and is discussed in the DLRC meeting dated 09.06.2025 for further consideration & recommendation. However, as the UDISE database for the year 2024-25 is already completed and any other years prior to 2024-25 has already been accepted, published and the concerning years are elapsed and as such considering all aspects, it is decided by the DLRC that the allotment of UDISE code for the school in the year prior to 2025-26 cannot be considered with retrospective effect.

After detail scrutiny, the school viz. BODOLAND PIONEER PUBLIC SCHOOL (PVT) is considered for assigning UDISE code for the year 2025-26 & RTE recognition under State RTE rules as recommended by the District Level Redressal Committee (DLRC) on the ground stated in the recommendation as quoted hereunder—

“Recommended for Allotment of UDISE Code for the year 2025-26 and RTE Recognition under State RTE Rules. Availability of 3-storeyed RCC Pucca school building in good condition. Sufficient classrooms for students. HM Room, Barrier Free Access. Adequate DW facility, Toilet, Playground, Boundary Wall, TLE, Library Books, Play materials, qualified teachers, enrolment & Leased Land and having prior permission order under "Assam Non-Govt. Educational Institution (Reg. & Mgt) Act, 2006".”

With the above order the representation of the petitioner stands disposed off accordingly.
